It appears Heather Voska Hartwig's response and certification may be in compliance with the ADMINISTRATIVE REGULATIONS For Court Reporting Services in the Illinois Courts but is not in compliance with Local Rule 1.08(c)(2) spelled out below.

Dear Paul,

By my signature on the certification page, the transcript I sent you is certified as an electronically recorded transcript transcribed to the best of my ability from the electronic recording. Since this transcript was not done by me live in the courtroom at the time of the proceeding, the fact that I'm a certified shorthand reporter or my license number, does not need to be included on the certification page. It is still considered certified by me as transcribing the transcript from the electronic recording.

I realize that many reporters do include their CSR license on the electronically recorded transcripts, but the license number is actually not necessary to be included on these types of transcripts. If you look back on the transcripts I emailed you in January, you will see the same setup for the certification page.
