1 THE COURT: Dulberg vs. Gagnon.

16 anything we need to do in rebuttal or update any
17 experts, I'll be able to tell you that.

18 THE COURT: Yeah, we'll have a lot of time if

21 we put it out 30 days, have that provided for in
22 the order.
