PLAINTIFFS' MOTION FOR EXTENSION OF TIME TO RESPOND TO THE BAUDIN DEFENDANTS' 735 ILCS 5/2-619.1 MOTION TO DISMISS PURSUANT TO ILLINOIS SUPREME COURT RULE 183

Now comes the Plaintiffs, by and through their Attorney Alphonse A. Talarico, and in support for their motion for Extension of Time state as follows.

- On May 18, 2023, this Honorable Court set a briefing schedule granting Plaintiffs' up
 to and including June 1, 2023 to Respond to the Baudin Defendants' Motion to
 Dismiss and granting the Baudin Defendants' up to and including June 15, 2023 to
 Reply. (Please see Plaintiffs' Exhibit A the May 18, 2023 Order attached)
- 2. On April 17, 2023 Michael D. McArtor, Plaintiff's lifelong friend, live in housemate and care giver was unexpectedly found dead with the manner of death described as "PENDING INVESTIGATION" (Please see Plaintiffs' Exhibit B CERTIFICATE OF DEATH RECORD attached)
- 3. Plaintiff Paul Dulberg thereafter had to not only contend with his own grief and loss of his caretaker, but also Michael D. McArtor out of state family for weeks following.
- From May 18, 2023 through the first week or so of June 2023 Plaintiff Paul R.
 Dulberg became uncommunicative generally and specifically with his attorney herein.
- 5. It was impossible for his attorney to properly craft a Response without communication from his client Paul Dulberg.
- 6. During at least four times within the period Attorney Alphonse A. Talarico was in communication by phone and email with the Baudin Defendants' Jeremy Boeder who kindly agreed to extend Plaintiffs' time for filing their Response.
- 7. The last communication between attorneys resulted, with this Honorable Court's permission/agreement to reset the briefing schedule dates to Plaintiffs' Response due

on or before June 22, 2023 and the Baudin Defendants' Reply on or before July 6, 2023.

WHEREFORE PLAINTIFFS PRAY THAT THIS HONORABLE
COURT grant the Motion for Extension of time and reset the briefing schedule as requested.
