In 17LA377 I have never received an 'independent opinion' in the form of a written report. May I please obtain a copy?

You also wrote, "As you have seen in the invoices and time provided to you, I earned and was paid \$4650 for my services leaving a balance of \$2550 in the retainer - to be promptly returned to the proper party in the Popovich case."

A -- To help you understand and explain / answer your question-

1-Your previous attorney ,Mr Talarico , engaged me as an Expert Witness in the Baudin case.

2-I then sent him an invoice dated April 12, 2023 for \$5400 which was the amount I requested for a retainer. He paid me directly - see a copy of his check following -

Please note and I hope you understand the role of an expert witness . I was engaged as an Expert Witness to provide an independent opinion in these two cases.


