Hi Julia.

A note on Mr Flynns claim that the black boxes are photocopies of file dividers:

- 1. I am a professional Graphic Designer
- 2. I opened each of the blacked out pages in both Adobe Photoshop and Adobe Illustrator
- 3. In illustrator the box appears to be a vector graphic or object, not a rasterized image, scan or photocopy
- 4. In Photoshop I used the info pallet and eyedropper tool and cannot detect any fluctuation in color.

The color is perfectly uniform throughout.

This is not possible from a scanned image or photocopy.

5. I will state unequivocally that the black box on each page is generated digitally and placed in the file. Meaning it is not a scan or photocopy of a file divider or anything else.
