Hi Julia,

I am requesting a meeting with you, Ed and my brother Tom within one week prior to Masts deposition. Lets find a time that works for both you and Ed and schedule this in.

Yes. We are available on June 22 or 23 at 2pm.

Also, I have 5 questions about the remote deposition:

1. Who will conduct the deposition, both you and Ed or just one of you, if only one which one?

I will conduct the deposition. Only one attorney can ask questions (we both cannot ask questions).

2. If this is a video deposition may we record the actual video of the deposition and use it later at trial?

No. It is a traditional deposition in that there will be a transcript that can be used at trial to impeach, just like we would have had if we weren't dealing the pandemic.

3. If this is to be an audio only deposition may we record the actual audio and use it later at trial?

Generally I believe the court reporter does record the audio for the purposes of correctly the transcript, but it is not available for use later. It is strictly to ensure that the transcript is accurate

4. Will Mast be in the same location as his attorney or will each of them attend from different locations?

As of now, Mast's attorney, George Flynn, will be present with him.

5. If mast is not in the same location as his attorney what guarantees do we have that no one else will be present?

At the beginning of the deposition, we will ask about who else is present in the room and ask they confirm by showing us the room. A party would be allowed to be present—since the Popovich Firm is a party, a representative from the firm, such as Tom Popovich, would be permitted to be present. However, he cannot interfere or prompt the witness. Any notes exchanged would be discoverable.

I have spoken to George Flynn about the logistics of the deposition and it is my understanding that Tom Popovich is not intending to appear at Hans' deposition. I will be sure to confirm prior to the date.

Communication with the witness through text or electronic means is not permitted, would be discoverable, and could open the other side up to sanctions. There are a few preliminary questions that we will ask at the beginning of the deposition to be sure that no one else is present, that all electronic communication is off, and that they are following the rules.

My concern here is coaching by Thomas Popovich or any other person with Mast that will not be in view of the camera or seen at all if this is audio only. Including coaching over text or other electronic means.
