Dear Paul,

As we stated previously, Dear Paul, we have approximately \$27,000 worth of work in your case, which would be the maximum that we could possibly request in the adjudication of our attorneys' lien. The attorneys' lien is for legal services rendered, not expenses. You paid the expenses in the case as the case progressed, thus, we do not have any out of pocket costs or expenses.

We are willing to reduce the lien and would work with any counsel to that end. We would also reduce the lien depending on the value of any settlement or award in the case. In other words, if you choose to settle the case for a smaller amount, we would not be seeking \$27,000 on our lien, rather we would take a much smaller percentage of any total award or settlement.
