Dear Mr Talarico,

I wanted to touch base today and update you on a couple items.

1. Below is the ongoing email conversation with the person assigned to make the transcript from the last court hearing.

It appears I am waiting for them to finish the transcript and get a final invoice before paying.

I am hoping to hear back from them soon on this.

2. My second surgery for removing the tumor has been scheduled for May 10th, 2021

As you know from last time, the two week recovery takes it to May 24th, 2021 and from what I experienced after the previous surgery the surgeon gave a very conservative time frame for recovery.

In reality it took me somewhere between 3-4 weeks before I was feeling well enough both physically and mentally to do anything substantial.

Just taking with you on the phone during the recovery period last time was like torture so I need a little time on this one.

Also, the week prior to the surgery is already filling up with all the pre-operative tests that need to be done. I am still waiting for the exact dates of a few of them.

In total I believe this all means approximately 5 weeks where I will not be in any position to help you or anyone else with much of anything.

This puts the total time I need away from the case from May 3rd through June 7th, 2021.

If we need anything from me or done by me I suggest we either complete it before May 3rd, 2021 or ask the judge now for a 5 week time extension.

I am sure opposing counsel will oppose and complain about the time extension but this surgery may be a little more extensive than the last and I will be unavailable for the full 5 weeks.

I have had no breaks from the underlying case nor this case since June 28th 2011 and my health needs this break irregardless of opposing counsels meaningless arguments.

I feel strongly about this 5 weeks and if the judge takes an issue with a medical timeout of 5 weeks Due to a major medical condition that must be addressed now then he can find me in contempt and put me in the county jail and they can pay for my medical while I am in their custody recuperating.

Either way I will be unavailable from May 3rd through June 7th, 2021.

How are you doing with the 8000+ pages and should I be looking at the interrogatories and supplementing the answers?
