Dear Mr Talarico,

The other day I sent you a time line of the Barch Letters and I mentioned that Mast/Popovich letters underwent a change in March of 2013.

I have not finished this 100% yet but if you simply scroll down the list of letters sorted by date below you will see the change that took place between March 12 and Mach 18, 2013.

It appears that Mast/Popovich changed putting the directory tree and file name on the letters they send out to completely removing any reference to a file name within the letters.

I am speculating/theorizing that either these were authored by two different people (one author before and a different author after the March 12 and Mach 18, 2013 change) or there was a policy change in what is okay and not okay to put on the letters.

I have no idea if this is useful for anything or not, it's just something I noticed and found odd and thought we should keep in mind when examining the documents.
