Dear Mr. Mast:

I am writing to confirm our telephone conversation earlier this morning, wherein I advised you that I was authorized to propose settlement of Mr. Dulberg's claim against Cicero and Bill McGuire for a lump-sum sum of \$250,000. The settlement would of course be contingent upon necessary settlement documents, including a release, a good faith affidavit, finding and disclosure.
